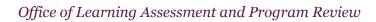

BA Accounting students met or exceeded acceptable and ideal targets for the Overall CPC Exam score with the exception of one. The CPC exam section for Business Policies, Integration, and Strategic Management section (PLO 4) were not met.

The End of Program Survey (EOPS) responses met or exceeded both the acceptable and ideal targets. The survey's results were based on responses specific to the following items: the curriculum was relevant to my professional needs and I understand the learning objectives of my courses.

Overall, it is recommended that Faculty review each 2013-14 assessment plan (including measures and targets set) in preparation for the 2014-15 assessment cycles. In addition, based on the data reported on CPC exam section for Business Policies, Integration, and Strategic Management section (PLO 4) it is recommended a more in depth focus is placed on this section.
