OVERALL RECOMMENDATIONS

During the 2013-14 assessment cycle, BA Early Childhood Education Administrations students did not meet the acceptable targets for half of the PLOs (PLOs 2, 5, and 6. It is highly recommended that College of Education faculty investigate the key assignments chosen for the following PLOs: PLO 1: the ECE 101 Week 2 Assignment, the ECE 312 Week 2 Assignment, and the ECE 430 Week 2 Assignment for PLO 3: the ECE 311 Final Paper, and the Instructional Strategies section of the ECE Exam, and for PLO 4: the ECE 311 Week 3 Assignment and the ESE 315 Week 3 Assignment. Overall, it is recommended that College of Education faculty review the assessment plans including measures used, targets set, and the curriculum map in preparation for the 2014-15 assessment cycle to ensure they remain appropriate and meaningful.
