Evaluation Summary for FINRA Qualification Exams

The University of Arizona Global Campus (UAGC) recognizes the uniqueness of each student's experience and realizes learning takes place in a variety of environments. The UAGC Prior Learning Assessment (PLA) program provides a means for awarding credit to students who bring college-level learning experiences acquired outside of a traditional university classroom setting, and which do not carry national testing program, American Council on Education (ACE), and/or National College Credit Recommendation Service (NCCRS) credit recommendation(s).

Specific FINRA Qualification Exams trainings have been evaluated by the PLA Department and credit recommendations have been determined. These recommendations are based on the training as taught when this guide was developed and do not constitute a guarantee that credit will be awarded. Students must follow the Sponsored Professional Training submission process and request an official review. Faculty provide final approval for any transferrable credit. Previous/future versions of each training may carry different credit recommendations.

All FINRA qualifications must be active to be considered for credit. No credit will be given for retired qualifications/exams when more than 2 years have passed with active broker-dealer registration.

Student Eligibility for PLA

Students are eligible to apply for PLA credit upon full admission into a UAGC undergraduate or eligible master's degree program. PLA credit may only be pursued when approval of PLA credits will fulfill unique remaining requirement(s) for graduation for the student.

Students are responsible for:

- Discussing PLA with their Academic Advisor.
- Reviewing the PLA Information Center located in the Student Portal.
- Submitting the required documentation.
- Submitting a PLA Sponsored Professional Training Credit Review Application.

Transfer Provisions

The transferability of credits is subject to the University of Arizona Global Campus transfer credit policies and requires the submission of official transcripts. The official transcripts will be evaluated by the Office of the Registrar to determine the credits that will officially apply toward a UAGC degree program. PLA credit may be pursued once the official transcript evaluation is complete. Credits must be earned at the same degree level in order to be applied. The PLA option is not available to non-degree seeking students or to students in specific graduate degree programs. Additional restrictions may apply.
