Student Eligibility for PLA

Students are eligible to apply for PLA credit upon full admission into a UAGC undergraduate or eligible master's degree program. PLA credit may only be pursued when approval of PLA credits will fulfill unique remaining requirement(s) for graduation for the student.

Students are responsible for:

- Discussing PLA with their Academic Advisor.
- Reviewing the PLA Information Center located in the Student Portal.
- Submitting the required documentation.
- Submitting a PLA Sponsored Professional Training Credit Review Application.

Transfer Provisions

The transferability of credits is subject to the University of Arizona Global Campus transfer credit policies and requires the submission of official transcripts. The official transcripts will be evaluated by the Office of the Registrar to determine the credits that will officially apply toward a UAGC degree program. PLA credit may be pursued once the official transcript evaluation is complete. Credits must be earned at the same degree level in order to be applied. The PLA option is not available to non-degree seeking students or to students in specific graduate degree programs. Additional restrictions may apply.
