

Overall, it is recommended to review the assessment plans (including measures used, alignment mapping, and targets set) and the curriculum map in preparation for the 2021-22 assessment cycle. This will determine the appropriateness of the assignments and mapping for each PLO.

Note by Sandra Rebeor: The PLOs were revised and implemented in 2022; numerous courses were replaced. ABS 300 was revised in Dec of 2021. Moving forward, we will replace PSY 301 and PSY 326 (no longer part of ABS program) with ABS 415 (final project) but retain ABS 300 and ABS 497 for assessment purposes. With the revision of ABS 300 and utilization of ABS 415 (rather than PSY 301), the goal is to raise the target percentage for these measures to 90% or above.
